OUR PROCESS

1. INITIAL INQUIRY

Upon receiving the inquiry, the client will receive an email, consisting of information about us, testimonials, inclusions list & new client questionnaire. Once the questionnaire has been returned an email will be sent to arrange a meeting to discuss your project in more detail.

2. INITIAL CONSULTATION

We will meet with you to review the client questionnaire and discuss the vision of your new home. This will involve an in depth look into your plan options, inclusions and any site specific requirements.

3. SKETCH PLAN & SPECIFICATIONS

If you do not already have your own plans, we will have our architect draw a sketch plan on your block of land. We will also complete a detailed set of specifications to ensure we can give the most accurate estimate possible.

4. INITIAL ESTIMATE

We will provide you with an estimate based on our discussions of your plans, specifications and site specific requirements.

5. PRELIMINAIRES INVOICE

If you are happy with the estimate provided, we will send you a preliminary invoice. This invoice is for plans, soil tests and engineering, which will enable us to provide you with a fixed price quote.

6. FIXED PRICE QUOTE

Now we have all the preliminary documentation, we then can provide you with a fixed price quote to build your new home.

7. CONTRACT PREPARATION

Once the fixed price quote has been accepted, the next step is to prepare the building contract. We will complete a draft building contract then arrange a meeting to review with you. Once accepted the building contract will be sent to you to be signed electronically.

8. PERMIT

The final stages before construction can start is to arrange all relevant documents to be submitted in preparation for the building permit to be issued.

9. CONSTRUCTION TIME

The fun begins! The preliminary process is now complete and we are ready to get started on building your new home!
